## **Final Order**

- 1. A Proposal has been filed by applicant school to determine fees for the year 2019 2020.

- 6. School has filed this proposal to determine fees for the year 2019-20. This Committee has gone through the papers submitted by the school along with proposal and passed order of provisional fees for the year 2019-20 on 30-08-2019.
- 7. Being aggrieved by the said order school has filed its objection vide letter dated 26-09-2019, therefore this committee has issued a letter dated 22-11-2019 and sought certain information along with certain documents.
